## **APPROVED THIRD PARTY ENERGY CODE INSPECTIONS AND TESTING.**

### **Sections C402.5.3 and R402.4.2, 2021 International Energy Conservation Code**

**C402.5.3 Building thermal envelope testing.** The building thermal envelope shall be tested in accordance with ASTM E779, ANSI/RESNET/ICC 380, ASTM E3158 or ASTM E1827, or an equivalent method approved by the code official. The measured air leakage shall not exceed . . .

**R402.4.1.2. Testing.** The building or dwelling unit shall be tested for air leakage. The maximum air leakage rate for any *building* or *dwelling unit* shall not exceed . . . . Where required by the *code official*, testing shall be conducted by an *approved* third party. A written report of the results of the test shall be signed by the party conducting the test and provided to the *code official*. Testing shall be performed at any time after creation of all penetrations of the *building thermal envelope* have been sealed.

The following companies have been deemed to meet PPRBD's qualifications of an approved third party to perform the required inspections and testing of sections C402.5.3 and R402.4.1.2 of the 2021 International Energy Conservation Code.
